- 2. Regulatory reports are to be forwarded to EPEA.Reports@aer.ca. This includes all reports required by the approval including, but not limited to industrial, reclamation, waste, soil monitoring, and groundwater monitoring.
- 3. Until further notice, for discussions related to the content of your air related reports please continue to forward your questions through air.reporting@gov.ab.ca.
- 4. Operational authorizations, proposals, and plans pursuant to an approval clause and in respect of an energy development are to be forwarded to: EPEA.WA.Plans.Authorizations@aer.ca. This includes but is not limited to soil monitoring proposals, groundwater monitoring proposals, plan authorizations, and director authorizations pursuant to an approval condition.
