Operational authorizations, proposals, and plans pursuant to an approval clause and in respect of an energy development are to be forwarded to: [EPEA.WA.Plans.Authorizations@aer.ca](mailto:EPEA.WA.Plans.Authorizations@aer.ca). This includes but is not limited to soil monitoring proposals, groundwater monitoring proposals, plan authorizations, and director authorizations pursuant to an approval condition.
