1. If you are involved in the electronic reporting of CEMS data there is currently no change to the reporting process.
2. Regulatory reports are to be forwarded to [EPEA.Reports@aer.ca](mailto:EPEA.Reports@ aer.ca). This includes all reports required by the approval including, but not limited to industrial, reclamation, waste, soil monitoring, and groundwater monitoring.
3. Until further notice, for discussions related to the content of your air related reports please continue to forward your questions through [air.reporting@gov.ab.ca](mailto:air.reporting@gov.ab.ca).
4. Operational authorizations, proposals, and plans pursuant to an approval clause and in respect of an energy development are to be forwarded to: [EPEA.WA.Plans.Authorizations@aer.ca](mailto:EPEA.WA.Plans.Authorizations@aer.ca). This includes but is not limited to soil monitoring proposals, groundwater monitoring proposals, plan authorizations, and director authorizations pursuant to an approval condition.
